- 7) Presentation of Missions Budget by Scott Arnwine from committee
 - a) Scott summarized the four ways to give to Missions and reported on the current budget.
 - i) Budget giving is 1% below the 2022-2023 giving, totaling \$333,300.
 - ii) Pass thru is ~\$980,000.
 - iii) The new budget is held at \$330,300.
 - b) Floor opened for discussion on the mission's financial report.
 - c) Motion made to accept the report, accepted by voice vote.
- 8) Treasurers Report and Proposed Budget by Rob Westmoreland, Treasurer.
 - a) 2022-2023 Treasurers Report
 - i) Giving July-April exceeded all years. Ministry fund is at an ail-time high at \$2.72-MM.
 - ii) A thank you to those giving.
 - iii) Motion made to approve the Treasurers Report, passed by voice vote.
 - b) 2023-2024 Proposed Budget from committee
 - i) Expense budget is mostly as previously budgeted, up 2.3%, totaling \$3.38MM.
 - Ii) The increase in the budget results from the added cost of security, increase in the cost of food service, and staff increases.
 - (1) Floor opened for discussion No questions asked.
 - iii) Motion made to accept the 2023-2024 Budget and the Budget accepted by voice vote.
- 9) Report from the Pastoral Search Committee by Eric Furman.
 - a) The search committee was recognized.
 - b) Progress to date and progress report Pathway to Pastor Next.
 - Candidates canvased from nine seminaries as well as an on-line portal and local network referrals.
 - ii) Eric reviewed the process for reviewing applicants thought the two subcommittees, Peace and Grace. The goal is to recommend a candidate.
 - iii) With the recommendation of Session, the congregation will be given the opportunity to vote.
 - iv) Data:
 - (1) 366 applications and referrals reviewed.
 - (2) 107 application and 25 referrals in 2023.
 - (3) 7 applicants given serious consideration.
 - (4) One applicant is in the final stages.
 - c) Eric explained the expectation of "Candidate Season."
 - d) The committee continues to pray and seek God's guidance in the pastoral search.

- 11) Election of new Chairman and Vice Chairman
 - a) Hal Stanley displayed Article I, Section 6.

 - d) Preston Klink voted to the position of Chairman by voice vote.

 - f) Motion to close nominations made, second and passed by voice vote.
 - g) Jordan Bernardini voted to the position of Vice Chairman by voice vote.
